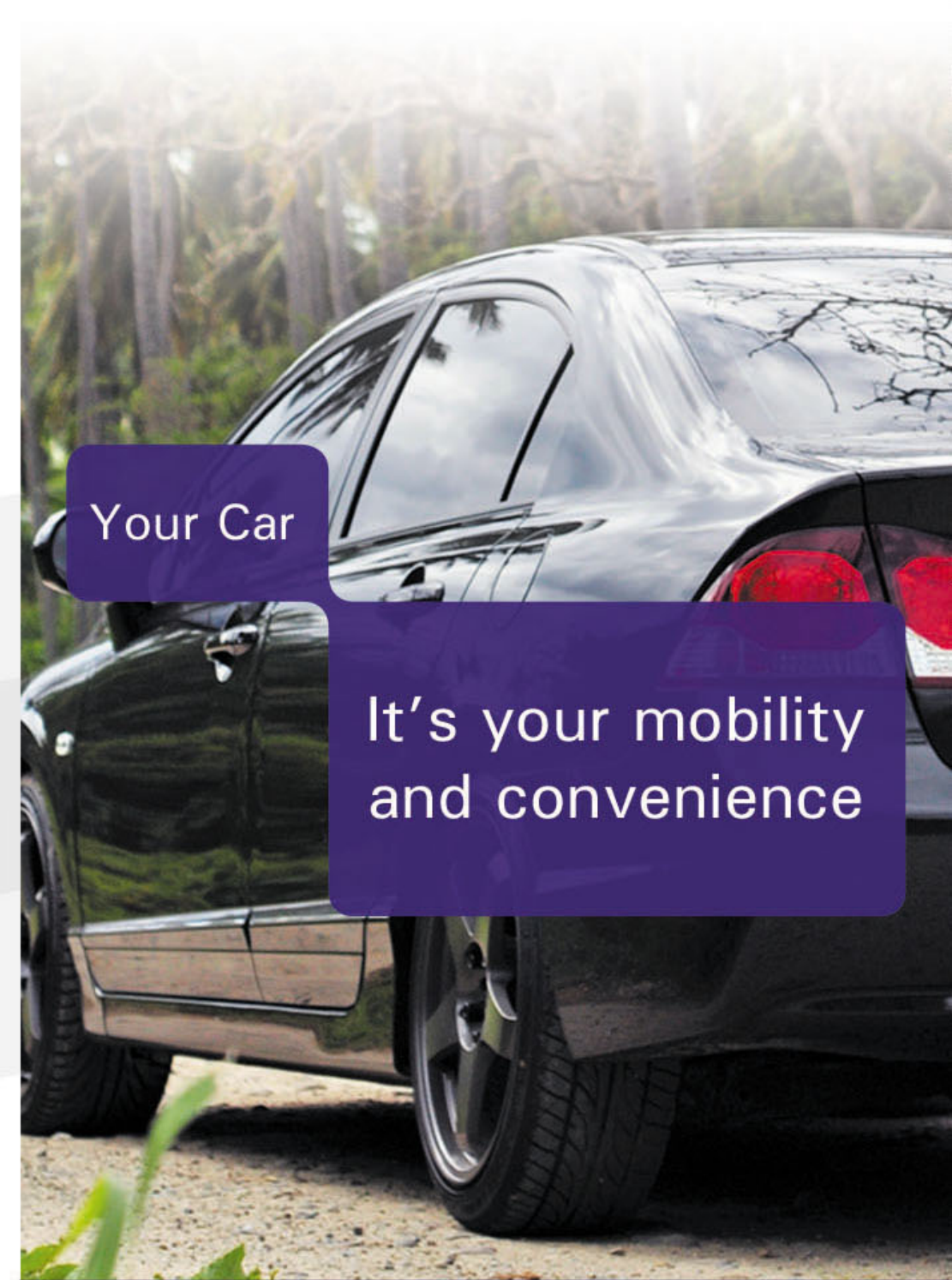

# Introducing AUTO Protector Plan

## What do we cover under our Auto Protector Plan?

The plan covers both (a) Private Cars which are used exclusively for social, domestic and pleasure purposes or profession of the insured and (b) Commercial Vehicles which are used for the insured's business especially for carrying of goods, except for carrying fare paying passengers or vehicles for hire.

## Who may be covered under the Plan?

The registered owner of the vehicle is deemed as the insured, or any person driving the vehicle with the insured's permission. It is essential that both the insured or the person driving upon the insured's order must be duly licensed by the Land Transportation Office.

## What are the items covered by the Plan?

- I. Compulsory Third Party Liability (CTPL)  
This is mandated by law wherein the insurer pays all sums, within the limits set forth in the schedule of indemnities, to discharge liability of the insured for bodily injury and/or death to a third party caused by an accident arising out of the use of the insured car/vehicle.
- II. Own Damage and Theft (OD/T)  
It covers partial or total loss of the car/vehicle caused by accidental collision or overturning, fire, external explosion, self ignition or lightning or burglary, housebreaking or theft, malicious act, or whilst in transit incidental to such transit by road, rail, inland, waterway, lift or elevator.
- III. Acts of Nature (AON)  
It covers partial or total loss of the car/vehicle caused by any natural disasters that we cannot foresee or prevent including typhoon and flooding, earthquakes, tornadoes, volcanic eruption, and any other naturally occurring catastrophe.
- IV. Excess Third Party Bodily Injury (ETP-BI)  
In excess of the limit cited under the Compulsory Third Party Liability, the insurer pays all sums, within the limits set forth in the schedule of indemnities, to discharge the liability of the insured to a third party for bodily injury.
- V. Third Party Property Damage (TP-PD)  
Similar to Item IV above, it affords protection to the insured against liability to a third party for property damage.
- VI. Auto Personal Accident for Passengers (AUTO-PA)  
It gives protection to the passengers of the insured car/vehicle for bodily injury or death resulting from an accident.

## What are not covered under the Plan?

### Private Cars

- > The insurer will not pay for consequential loss, depreciation, wear and tear, mechanical or electrical breakdowns, failure breakages, damage to tires unless the car/vehicle is damaged at the same time, malicious damage caused by the insured, members of his family or employees of the insured.
- > Cars over 12 years old.

### Commercial Vehicle

- > In addition to the exclusions cited under Private Car above, the insurer will not likewise settle any damage caused by overloading or strain, explosion of any boiler, or damage to any bridge, weighbridge or viaduct or to any road and death, bodily injury or damage caused or arising beyond the limits of any carriageway.
- > Vehicles over 12 years old.
